Her leadership responsibilities include oversight of human resources and services, auxiliary services, information technology, facilities management, environmental and emergency management, public safety, and enrollment management. Under her leadership, Howard University has experienced significant growth in its enrollment growth and in turn, its financial outlook. Prior to this role, she served as the 17th president of Shaw University.



MSNBC Host of SYMONE

Symone Sanders-Townsend is an author, seasoned democratic strategist and host of "SYMONE" on MSNBC and MSNBC on Peacock. Symone's namesake show provides essential context on the most pressing issues facing Americans today and creates the discourse missing in the media. Symone rose to prominence in 2016 as the national press secretary for U.S. Senator Bernie Sanders's then-presidential campaign. At 25, she became the youngest presidential press secretary on record and was named to Rolling Stone Magazine's list of 16 young Americans shaping the 2016 election. Symone was later appointed as a senior member of the Biden-Harris administration. Symone is an alumna of Girls Inc. of Omaha.

#### **ABOUT OUR FOUNDER**

#### DR. ROSELYN ELIZABETH PAYNE EPPS



Roselyn Payne Epps, M.D., M.P.H., was born in Little Rock, Arkansas, the daughter and granddaughter of educators. Dr. Epps attended elementary school at Powell Laboratory School in Savannah, GA, and graduated from Palmer Memorial High School in Sedalia, NC. She graduated from Howard University in Washington, D.C., with undergraduate and Doctor of Medicine degrees, with honors. She also earned the Master of Public Health from Johns Hopkins University, Baltimore, MD and Master of Arts in Interdisciplinary Studies from American University, Washington, DC.

Dr. Epps completed her internship and pediatric residency at Freedmen's Hospital (now Howard University Hospital). After training and private practice, her public health career began with the DC Department of Health in the well-baby clinics. She rose within the DC Department of Health, served as Chief of Bureau of Maternal and Child Health and Bureau of Clinical Services, and in 1980 was appointed the first Commissioner of Health of the District of Columbia.

After leaving DC government in 1981, she returned to Howard as Professor in the Department of Pediatrics and Child Health, where she would become the Chief of the Child Development Division and Director of the Child Development Center. While there, Dr. Epps oversaw programs assisting disabled children and their parents, and founded the High-Risk Young People's Project, which brought together several university health science departments, community organizations, and government agencies within DC. In 1989, Dr. Epps joined the National Cancer Institute, National Institutes of Health, Bethesda, MD, focusing on cancer prevention nationally. Dr. Epps served as a requested and respected consultant in the public and private sectors, nationally and internationally. Epps authored more than 90 articles for medical publications and was a co-editor of The Women's Complete Handbook.

Dr. Epps was a pioneer and leader in many professional and service organizations. Among her many firsts included the first African American and female president of the DC Chapter of the American Academy of Pediatrics, and first African American president of the American Medical Women's Association. She served in many professional, service, and philanthropic organizations, and was the recipient of more than 60 awards. The Council of the District of Columbia declared February 14, 1981, as Dr. Roselyn Payne Epps Day across DC.

Dr. Epps' leadership included national president of Girls Incorporated, 1990 to 1992, and founded Girls, Inc. of the Washington, D.C. Metropolitan Area in 2004. Dr. Epps passed away in 2014. She was married to classmate Charles H. Epps, Jr., M.D., and they raised four children.
